### **“UNSUNG HERO AWARD” NOMINATION FORM**

#### **CRITERIA**

This Unsung Hero has gone above and beyond the call of duty. This is a special person who has done extra special things for our community. Those in need, or for someone unable to do things for themselves, in relation to life saving, health and welfare, community involvement and betterment. This special person has done the good works without receiving pay or expecting praise or recognition.

This is a person who in terms of the Rotary motto puts service above self, but who is not a Rotary member.

All nominations will be reviewed by the Marco Island Sunrise Rotary Board of Directors and the Board will select the award recipient.

The nominee must reside in Marco Island, Florida at least 6 months of the year, or be employed and working in such employment on Marco Island at least 30 hours per week or is being nominated for service provided on Marco Island.

The guidelines for selecting the recipient of the Unsung Hero Award include the following:

- 1. The recipient should be a volunteer who has worked in the community without recognition.
- 2. The recipient should be selected for community work that is not related to Rotary activities.
- 3. The recipient should be someone who has not been honored by an organization or public testimonial.
- 4. The recipient should be someone who has not held office in the sponsoring organization.
- 5. The recipient should be generally unknown to the majority of the community.
- 6. The service for which the nominee is nominated should have taken place within 12 months preceding the date of nomination (if ongoing, can begin prior to that date).
